

ADVERTISEMENT FOR BIDS

The **Lac du Flambeau Band of Lake Superior Chippewa Indians** is seeking bids for the construction of the **“W. River Terrace – Bridge Replacement Project”** that includes the following major items of work:

- **Removal of existing bridge, concrete masonry bridge replacement with prestressed concrete girders, CIP piles, HMA paving, borrow, clearing and grubbing, riprap, aggregate shoulders, and related work.**

Interested parties may view the contract documents at no cost on the website prior to becoming a plan holder. Downloading and printing the contract documents will require registering with QuestCDN online (www.questcdn.com). A non-refundable fee of \$22.00 will be charged to download the contract documents.

Paper copies of the contract documents may be obtained by contacting Coleman Engineering Company. A non-refundable fee of \$50.00 will be charged for each hard copy set of the contract documents.

To be considered a plan holder for bids, a contractor must purchase the contract documents. Registering as a plan holder is required for all prime contractors and subcontractors, as plan holders will receive addenda and other contract document updates via QuestCDN. The plan holders’ list will be available at www.coleman-engineering.com.

Proposals must comply with the requirements set forth in the RFP and addenda and be submitted, with copies, in a sealed envelope marked **“RFP For W. River Terrace – Bridge Replacement Project”** and bearing the name and address of the bidder. **Deadline for submission of sealed proposals is 12:00 Noon, Local Time, Thursday, April 30, 2026.** Bids will be opened thereafter. Bidders may be asked to attend an interview prior to bid award. The successful bidder will be expected to begin contract performance as soon as possible.

The Tribe reserves the right to accept or reject any and all bids at its discretion, to waive technical defects and make the award to the bidder most competent to serve the Tribe's requirements.

No bid shall be accepted unless accompanied by a bid security payable to the Lac du Flambeau Band of Lake Superior Chippewa Indians in an amount not less than 5% of the base bid.

Prevailing wage rates will be required for this project.
