Nonexempt Position Description**

A. TITLE OF POSITION: Mental Health Counselor/Psychotherapist

B. DEPARTMENT: Family Resource Center

C. SUPERVISOR'S TITLE: Family Resource Center Clinical Director

D. DESCRIPTION OF DUTIES: As supervised by the Clinical Director and appropriate designees, the primary responsibility of this position is to provide mental health counseling to community members with a strong focus on working with children and families across the life span. Specific duties include but are not limited to:

1. Provide direct face to face or telehealth counseling services to children and families, individuals, couples, and group therapy formats.
2. Provide clinical assessments, diagnostic evaluations, psychotherapy, client advocacy and crisis intervention.
3. Maintain a confidential, timely, and accurate client record keeping system in accordance with program and state guidelines.
4. Document all client contacts in EHR.
5. Provide mental health services to local Head Start program.
6. Provide outreach services to area schools, agencies, and make home visits as needed.
7. Maintain a professional and cooperative relationship with all programs involved with providing services to the tribal community.
8. Complete CCS provider education and training to provide services and participate on teams for consumers enrolled in the CCS program.
9. Attend and actively participate in all scheduled meetings including weekly intake, supervision, and case management meetings.
10. Provide client list for State Certification files monthly.
11. Participate in all quality assurance/quality improvement projects including regular peer audits and reviews.
12. Work towards maintaining requirements of AAAHC certification and conducts appropriate follow up.
13. Perform other duties as assigned.

E. POSITION RELATIONSHIPS:

1. **Internal:** Monthly contact with outreach services, schools, and other agencies and other social service agencies.
2. **External:** Frequent contact with children, families, individuals, couples, and groups.

F. SUPERVISORY RESPONSIBILITIES: None

G. SUPERVISION RECEIVED: Operates independently with supervision received from FRC Clinical Director. Supervision toward 3,000 hours will be provided.

H. EDUCATION: Master's degree in psychology, counseling, social work or related field.

I. LICENSURE: Required to hold and active State of Wisconsin license or certification which may include APSW, LPC-IT, LCSW, LPC, LMFT. Must be able to bill for medical assistance and other third-party insurances.

J. EXPERIENCE: Providing assessment and treatment services in a mental health program, with strong skills in working with children and families, also working with Native American individuals and families.

K. SKILLS: Basic knowledge of chemical dependency and effects on children and families. Must obtain and maintain current Heart Saver or Basic Life Support Certification.

L. WORKING ENVIRONMENT:

1. **Work Conditions:** . Work primarily in an office setting, but may be required to leave the office occasionally to meet with clients, families, and other professionals in meeting responsibilities of this job.
2. **Exposure to Hazards:** None
3. **Physical Requirements:** Requires standing, sitting, walking, bending, and light lifting.

M. BEHAVIOR: The vision, goals and objectives of the Lac du Flambeau Band of the Lake Superior Chippewa Indians requires the Mental Health Counselor/Psychotherapist to perform in both a professional and personable manner. The manner in which the employee relates to fellow employees, customers and visitors is considered parallel in importance to technical knowledge and ability. Respect and consideration given to the dignity of each customer, visitor and fellow employee is a requisite of successful job performance. Any attitude or behavior that will tarnish the name or reputation of the Lac du Flambeau Tribe will not be tolerated and is subject to disciplinary action.

N. OTHER: Demonstrate a strong commitment to cultural beliefs and values of the Lac du Flambeau Band of Lake Superior Chippewa Indians and the governing Tribal Council. Practices cultural sensitivity at all times, recognizing the respective diverse work styles within the organization and the Lac du Flambeau community. Must submit to a drug test prior to commencing employment and random testing thereafter. Criminal background check required applicable to the job description. As an employee of the Tribe, he/she will be subject to the Policies and Procedures of the Lac du Flambeau Band of Lake Superior Chippewa Indians. Employee must provide proof of vaccines or of immunity to measles, mumps, rubella, and varicella at the time of employment and must submit to a TB test.
